What information we collect, use, and why

We collect or use the following information to **provide services and goods, including delivery**:

- Names and contact details
- Addresses
- Date of birth
- Purchase or account history
- Payment details (including card or bank information for transfers and direct debits)
- Account information

- Website user information (including user journeys and cookie tracking)
- Call recordings
- Records of meetings and decisions
- Information relating to compliments or complaints

We collect or use the following information for **the operation of customer accounts and guarantees**:

- Names and contact details
- Addresses
- Payment details (including card or bank information for transfers and direct debits)
- Account information, including registration details
- Marketing preferences

We collect or use the following information for **service updates or marketing purposes**:

- Names and contact details
- Marketing preferences
- Location data
- IP addresses
- Website and app user journey information

We collect or use the following personal information for **dealing with queries, complaints or claims**:

- Names and contact details
- Address
- Payment details
- Account information
- Purchase or service history
- Call recordings

- Customer or client accounts and records
- Financial transaction information
- Correspondence

Lawful bases and data protection rights

Under UK data protection law, we must have a “lawful basis” for collecting and using your personal information. There is a list of possible [lawful bases](#) in the UK GDPR. You can find out more about lawful bases on the ICO’s website.

Which lawful basis we rely on may affect your data protection rights which are set out in brief below. You can find out more about your data protection rights and the exemptions which may apply on the ICO’s website:

- **Your right of access** - You have the right to ask us for copies of your personal information. You can request other information such as details about where we get personal information from and who we share personal information with. There are some exemptions which means you may not receive all the information you ask for. [Read more about the right of access.](#)
- **Your right to rectification** - You have the right to ask us to correct or delete personal information you think is inaccurate or incomplete. [Read more about the right to rectification.](#)

Our lawful bases for the collection and use of your data

Our lawful bases for collecting or using personal information to **provide services and goods** are:

- Consent - we have permission from you after we gave you all the relevant information. All of your data protection rights may apply, except the right to object. To be clear, you do have the right to withdraw your consent at any time.
- Contract – we have to collect or use the information so we can enter into or carry out a contract with you. All of your data protection rights may apply except the right to object.
- Legal obligation – we have to collect or use your information so we can comply with the law. All of your data protection rights may apply, except the right to erasure, the right to object and the right to data portability.
- Legitimate interests – we’re collecting or using your information because it benefits you, our organisation or someone else, without causing an undue risk of harm to anyone. All of your data protection rights may apply, except the right to portability. Our legitimate interests are:
 - We may collect and process personal information from potential clients for the purpose of marketing our services and from clients for the purpose of fulfilling contractual obligations. The collection of personal information is essential for delivering the services and goods our clients expect. For potential clients, we only process personal data to communicate relevant information about our services, respond to inquiries, and provide personalized offers. This helps ensure that we can meet the specific needs of individuals and businesses looking for our expertise. For clients, we collect personal data to facilitate the creation, management, and execution of contracts, ensuring that we can provide services, manage billing and payments, and comply with legal obligations. Individuals have the right to opt out of marketing communications at any time, ensuring they maintain control over their personal data.

How long we keep information

We store information as follows:

For Marketing Purposes: Up to 3 years, unless the individual engages with our services or gives us consent to continue receiving our communications.

For Contractual or Legal Obligations:

- **Clients and Contracts:** Data collected for contracts or legal purposes will be retained for as long as necessary to fulfill the contractual obligations and to comply with any applicable laws (e.g., tax, accounting, or regulatory requirements), which is commonly up to 7 years is common.
